

## GENERAL REGULATION FOR VISITORS

Italian Exhibition Group S.p.A. (hereinafter also referred to as "IEG") has adopted the following General Regulations for Visitors. These regulations set out the rules of behaviour for visitors who intend to access the Exhibition Center, by:

- registering at any of the registration desks located at the entrances of IEG;
- pre-registering online through IEG's websites.

These rules are intended for all the Visitors attending the Shows and/or Events organized or hosted by IEG.

By signing this document, the Visitor undertakes to comply with all the rules contained herein.

### PROHIBITED BEHAVIOUR

#### SALE OF PRODUCTS INSIDE THE EXHIBITION CENTER.

Sales of products inside the Exhibition Center are strictly prohibited. In case of breach of this rule, IEG shall have the right to request the intervention of the police authorities, who will take all the necessary measures against the violator. IEG shall have the right to ask the Visitor to return the entrance ticket issued for free movement within the Exhibition Center.

**DISTRIBUTION AND/OR DISSEMINATION OF PROMOTIONAL AND ADVERTISING MATERIALS INSIDE THE EXHIBITION CENTRE.** It is forbidden to distribute and/or disseminate promotional and advertising materials inside the Exhibition Center. Visitors caught carrying out such activities shall be required to return immediately the entrance ticket issued for free movement inside the Exhibition Center

#### PHOTOS/VIDEOS

Visitors are expressly prohibited from taking photos and videos inside the Exhibition Center, unless they have been granted a specific authorization by the IEG General Management. The prohibition includes: photographs and videos made with any type of equipment (smartphones, tablets, digital cameras, cameras, etc.), as well as drawings or audio recordings. In the event of such breach, IEG reserves the right to protect its copyrights and other related rights in all competent jurisdictions.

By accessing the trade show, the Ticket Holder enters a public place.

In this regard ITALIAN EXHIBITION GROUP SPA informs that, through its own staff and / or specifically assigned professionals, it will proceed to acquire photographic images and / or generic video footage, to document and promote the event on its website, on editorial products connected to it and on any other paper and digital information media. If the Holder does not wish to be photographed and / or captured in a recognizable manner and that the minor accompanying and for whom he is responsible is requested, please communicate this to the recognizable operator thanks to the appropriate pass.

The Ticket Holder will not be entitled to any compensation or compensation whatsoever for the use of the aforementioned materials.

ITALIAN EXHIBITION GROUP SPA does not guarantee the darkening of any third party independent data controllers on online channels.

14.2 The Ticket Holder also acknowledges that all the external and internal areas of the exhibition center, for security reasons, are subject to video surveillance and that the recorded images are treated, as required by the Privacy Guarantor, in accordance with the general regulation in protection of personal data. Said images, upon the occurrence of criminal events or of particular relevance from the point of view of order and public safety, will be made available to the judicial or judicial police authorities, if requested.

#### NO SMOKING

Smoking is strictly prohibited throughout the Exhibition Center.

Any breach of this rule shall be punished, in accordance with Article 51, Law 3/2003, published in the Official Journal of 10 January 2005,

with an administrative fine of no less than € 27.50 and no more than € 275.00. Please note that, in compliance with the above-referenced

law, said fine is doubled if the violation is committed in the presence of a pregnant woman, infants or children up to 12 years.

Special smoking areas have been set up inside the Exhibition Center.

#### VISITORS' QUALIFICATION AND ENTRANCE TICKET

- At the time of registration, all visitors must provide truthful information about their identity and business. In case of false representations, the person concerned shall be liable to be prosecuted as prescribed by law.
- The entrance ticket is valid for a single day. It is not allowed to leave the Exhibition Center temporarily and return on the same day without purchasing an additional ticket.
- The entrance ticket stamped at the turnstiles may not under any circumstances be refunded (article 74, Presidential Decree no. 633/1972).
- The ticket must be saved and shown in case of checks whenever requested by the staff, until the Visitor permanently leaves the Exhibition Center.
- To qualify for reduced rates, the listed categories of Visitors must show an identity document or a document demonstrating their business activity, issued by the competent authority and currently valid.
- Because of the particular type of Event, dogs accompanied by their owners or keepers are allowed, provided they are kept on leash and muzzle and subject to compliance with all applicable regulations.

#### LIABILITY

IEG shall not accept any liability with regard to:

- Personal injuries or damage to property, inside the Exhibition Center, unless the

damage is caused by acts attributable solely to IEG.

- False and/or misleading information disseminated through promotional or advertising materials distributed by third parties not authorised by the IEG General Management.

ITALIAN EXHIBITION GROUP SPA reserves the right to cancel and / or reschedule the Events and / or Shows provided for in its calendar.

In this case, the refund of the admission ticket will take place exclusively in the event of cancellation and / or reprogramming by ITALIAN EXHIBITION GROUP SPA in the manner established by law.

The Ticket Holder also acknowledges that certain facts such as adverse weather conditions, reasons of security and public order, causes of force majeure or other organizational factors not attributable to ITALIAN EXHIBITION GROUP SPA could lead to changes in the dates and times of the event / event. ITALIAN EXHIBITION GROUP SPA is excluded from any liability in the presence of such situations.

ITALIAN EXHIBITION GROUP SPA cannot in any way be held responsible in the event that the holder of the entrance ticket, for reasons independent of causes attributable to ITALIAN EXHIBITION GROUP SPA, does not participate in the exhibition. No refund, in this case, will be due to the buyer.

ITALIAN EXHIBITION GROUP SPA will not be liable in any way for any further costs, charges, expenses, damages incurred by the ticket holder.

#### ACCESS FORBIDDEN

In addition to what is already indicated by the Consolidated Law on Public Safety Laws (TULPS) for security reasons, access to the fairgrounds is forbidden to persons in possession of own weapons (Article 30) and also to persons in possession of toy weapons, stun devices, blunt instruments, work tools, explosives and incendiary substances and devices and toxic chemicals. Any waivers can be issued only by the Management of Fair Ground.
